As of Jan. 4, a new law amending the Michigan Public Health Code (MCL 333.16148) requires all licensed health care professionals in the state of Michigan to complete training to identify victims of human trafficking.

- recognize the warning signs of human trafficking in health care settings for adults and minors
- identify resources for reporting the suspected victims of human trafficking
